

Terrance Stanton has been a Training Officer with the Bexar County Juvenile Probation Department since March 2000. Mr. Stanton holds a Master Public Administration Degree and a Bachelor of Arts Degree in Criminal Justice from the University of Texas at San Antonio. Mr. Stanton started with the Bexar County Juvenile Probation Department in 1997 as a juvenile detention center officer. He provides training primarily to the institutional staff in topics such as verbal de-escalation, the Mandt System, CPR, and First Aid among other topics. Mr. Stanton is also a trainer with the Correctional Management Institute of Texas based at Sam Houston State University in Huntsville, Texas where he provides training to both entry-level juvenile probation officers and detention officers.
