 - o <u>In-House:</u> about 85 juveniles participating in the GYSD kick-off on April 11th. The juveniles will be presenting power points of topics about El Paso's history. The topics are El Paso Police dept, City of El Paso, Missions, UTEP, Concordia Cemetary, Ft.Bliss/Star on the mountain. We will have County Commissioner Carlos Leon, Precinct 1, as our guest speaker.
 - o Community: To revitalize a historical El Paso Landmark, and mobilize our youth through community engagement and education of local history, the El Paso County Judge Enrique H. Peña Juvenile Justice Center along with its Community Improvement Program is ready to provide and enhance juveniles community service learning involvement by participating in Global Youth Service Day at Trinity Community Center on April 12, 2014 – April 13, 2014 from 7:30am to 3pm. Juveniles will participate in the clean-up and revitalization of the Trinity Community Center, which will include a mural, grounds landscaping, and building maintenance with community partner West Texas Community Supervision Department in order to beautify and enhance an El Paso Landmark. These community participants are made up of adult probationers, young juveniles from the El Paso County Judge Enrique H. Peña Juvenile Justice Center, Bowie High School, and various leaders from the community such as Judges, City Leaders, and County Commissioners. The El Paso County Judge Enrique H. Peña Juvenile Justice Center participants along with Youth Service America and various local community businesses, organizations and other supporters from the community will be honored to provide the participation and leadership in this important event, Global Youth Service Day.

Change happened starting, on April 12 13, 2014 (Saturday & Sunday) when over 50 youth/juveniles concentrated their efforts towards a revitalization of a local El Paso Landmark that has stood its test of time since the early 1890's. This change will hopefully bring positive attention and pride to an already impoverished area of El Paso, TX. The facility has a long history of bringing change to the El Paso Region, locally and nationally. And, hopefully this event will continue to move forward and our youth will learn to take pride in their communities, and in them. More importantly, we hope our youth realize no matter kind of past they may have had...they can always change for the better and move forward into a positive, productive way of life, similarly like the building they worked on.
